<b>Analyte description</b>	ST2 is an interleukin-1 family receptor expressed in the heart. ST2 protein has two isoforms: a soluble (sST2) and membrane-bound form. Patients with heart failure and elevated ST2 protein levels in the blood are at risk for heart failure progression.
